

## Arizona Private School Tax Credit Program and School Tuition Organizations (STO)

The Arizona Private School Tuition Tax Credit Law, (A.R.S. AZ 43-1089), allows Arizona taxpayers to contribute to a qualified School Tuition Organization (STO) and receive a dollar-for dollar state tax credit. The contribution may be recommended for a private school, such as **Summit School**, or for a student attending a private school in Arizona.

## **Summit School collects Tax Credits:**

Arizona state law prohibits parents from making a private school tax credit on behalf of their own child; therefore, Summit School greatly appreciates your tax credit contribution made to **The Institute for Better Education**, (**IBE**) on behalf of Summit School. Our school utilizes tax credit contributions to fund our need-based, student tuition assistance awards each year.

## **Recommended Student Tax Credits:**

Arizona taxpayers may also contribute to a STO and recommend a student, attending a private school as the recipient. Parents set up their student's tax credit account by selecting their preferred STO and completing the STO's annual application. A new application is required each spring with recent pay statement(s). Then parents let their family and friends know about the Tax Credit and how to make a tax credit contribution on behalf of their student(s) through their preferred STO.
